

**Agreement Between  
Kiwaniis Club of Fremont and

This agreement is entered into between The Kiwanis Club of Fremont and the following Non-Profit Selling Organization:

The purpose of this agreement is to allow the Non-Profit Selling Organization to participate in the 15th Annual Tri-Cities' Ducks for Bucks Benefit Race (2009) by selling Duck Race Entries as a fundraiser for its group. The rules are set forth as follows:

For each \$5.00 Racing Duck Sponsorship Entry that the Non-Profit Selling Organization generates as indicated in the official entry form, the Non-Profit Selling Organization will receive a minimum of \$3.00 \* per entry for the first 250 entries sold and a maximum of \$4.00 \* for all entries sold of 251 or more. *Please note that complementary ducks do not count towards the Selling Organization's earnings.*

The remaining \$2.00 (if sales are 250 entries or less) or \$1.00 (for sales exceeding 250 entries) will be retained by The Kiwanis Club of Fremont to support charitable programs and, if necessary, to help defray the expenses of the event.

The Non-Profit Selling Organization also agrees to have a representative attend at least one training class (entry forms will not be distributed until training has been completed) and to use only approved marketing and promotional literature. All marketing and promotional efforts must be pre-approved by The Kiwanis Club of Fremont. Failure to obtain approval could result in termination of this agreement.
